Measuring Circuit :



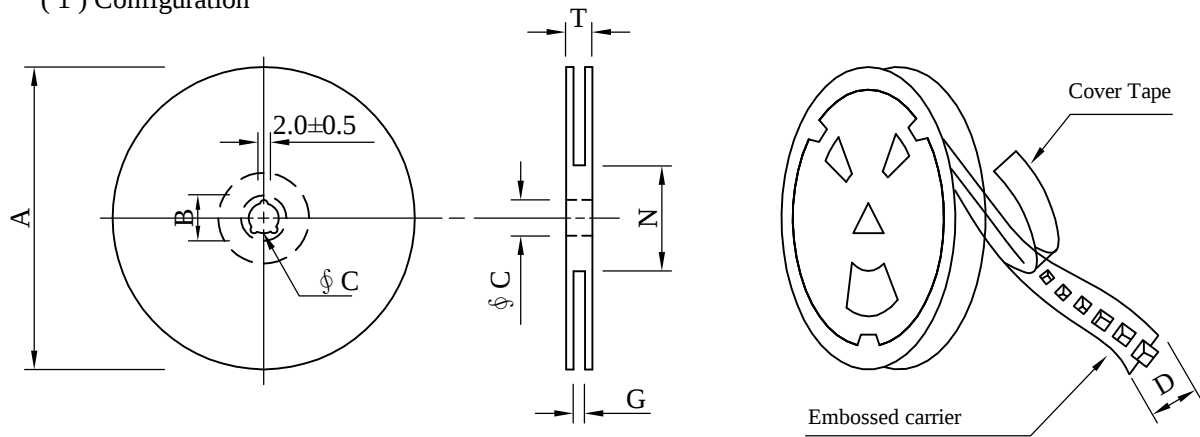

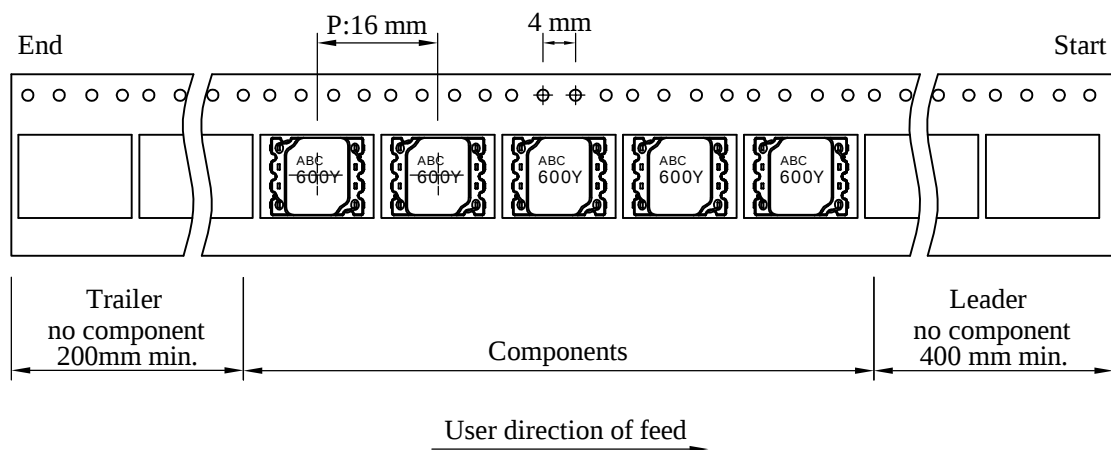

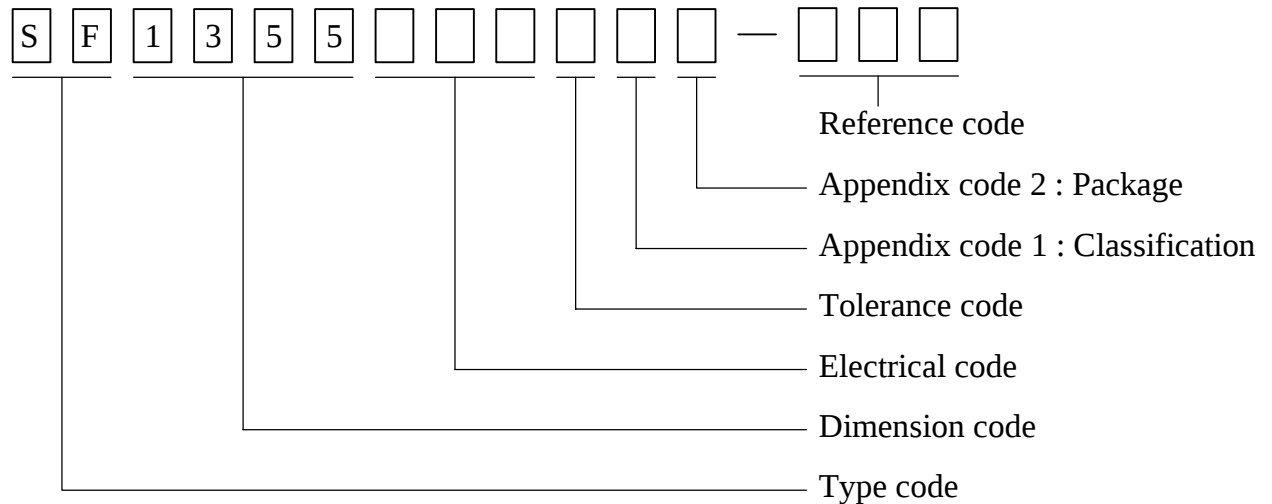
